The Department of Labor and Employment Regional Office VIII Bids and Awards Committee now invites bids for the Supply and delivery of 184 sacks good quality white rice and 23 units weighing scales, fabrication of 14 units Nego karts, 3 units sewing machines, 40 units pedicabs and tools, equipment, grocery items for the implementation of diversified livelihood of NLFO. Delivery of the Goods is required within 30 working days from receipt of the Notice to Proceed. Bidders should have completed, within two (2) years from the date of submission and receipt of bids, a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II. Instructions to Bidders.

3. Bidding will be conducted through open competitive bidding procedures using a non-discretionary "pass/fail" criterion as specified in the 2016 Revised Implementing Rules and Regulations (IRR) of Republic Act (RA) 9184, otherwise known as the "Government Procurement Reform Act".

Bidding is restricted to Filipino citizens/sole proprietorships, partnerships, or organizations with at least sixty percent (60%) interest or outstanding capital stock belonging to citizens of the Philippines, and to citizens or organizations of a country the laws or regulations of which grant similar rights or privileges to Filipino citizens, pursuant to RA 5183.

4. Interested bidders may obtain further information from the BAC Secretariat, Internal Management Services Division, Second Floor, DOLE Bldg., Trece Martires St., Tacloban and inspect the Bidding Documents at the address given below during 8:00AM to 5:00 PM.

A complete set of Bidding Documents may be acquired by interested Bidders on 24 July – 18 August, 2020 from the address below and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Hundred Pesos Only (₱ 500.00)/lot.

It may also be downloaded free of charge from the website of the Philippine Government Electronic Procurement System (PhilGEPS) and the website of the Procuring Entity, provided that Bidders shall pay the applicable fee for the Bidding Documents not later than the submission of their bids.

6. The DOLE RO VIII Bids and Awards Committee will hold a Pre-Bid Conference on 3 August 2020 at 2:00 PM at the Second Floor Conference Room, DOLE Bldg., Trece Martires St., Tacloban City, which shall be open to prospective bidders.

7. Bids must be duly received by the BAC Secretariat at the address below on or before 1:30 PM on 18 August 2020. All Bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in ITB Clause 18.

Bid opening shall be on 18 August, 2020 at 2:00PM at the Second Floor Conference Room, DOLE Bldg., Trece Martires St., Tacloban City. Bids will be opened in the presence of the bidders' representatives who choose to attend at the address below. Late bids shall not be accepted.
